THE FAMILY PLACE: THE FAMILY PLACE (TFP) HAS TOUCHED THE LIVES FOR MORE THAN 3100 ADULTS AND 4900 CHILDREN SINCE OPENING THE DOORS IN 2001. FOR 16 YEARS, TFP HAS DELIVERED RAMSEY COUNTY A SAFE AND APPROPRIATE DAYTIME PLACE FOR HOMELESS FAMILIES WITH CHILDREN-PROVIDING BASIC NEEDS: THREE HEALTHY MEALS AND A SNACK EACH DAY; SHOWER, LAUNDRY, AND STORAGE FACILITIES; CHILDCARE; A COMPUTER ACCESS AREA; A PICK UP AND DROP OFF LOCATION FOR SCHOOL-AGED CHILDREN; AND A SPECTRUM OF OTHER ESSENTIAL SERVICES TO HELP FAMILIES REGAIN STABILITY. FOR MORE THAN A DECADE, IT REMAINED THE ONLY DAY SHELTER FOR FAMILIES IN RAMSEY COUNTY. MOST RECENTLY, TFP HAS ADDED BOTH A NIGHT SHELTER PROGRAM AND AN INNOVATIVE EDUCATION PLATFORM (GOING HOME), DESIGNED FOR EVERY MEMBER OF A FAMILY IN TRANSITION.
